

2017 HANDICAP GOLF CART REGULATIONS



HERITAGE SHORES

DUE TO OUR INCREASE IN MEMBER & PUBLIC PLAY, THE GOLF COMMITTEE AND THE HERITAGE SHORES PGA PROFESSIONAL STAFF DECIDED IT WAS NECESSARY TO CREATE SOME STANDARDS AS IT RELATES TO HANDICAP GOLF CART USAGE. THESE REGULATIONS WERE DESIGNED TO BETTER SERVE OUR GOLFING COMMUNITY AND THOSE PATRONS WHO TRULY NEED A HANDICAP GOLF CART.

- NO HANDICAP FLAGS ARE TO BE USED ON DAYS WHEN THE GOLF COURSE IS 90 DEGREES WITH THE GOLF CARTS.
- TO BE ELIGIBLE FOR A HANDICAP FLAG, AN INDIVIDUAL MUST SHOW A COPY OF A DISABILITY/HANDICAP CARD TO A HERITAGE SHORES PROFESSIONAL STAFF MEMBER. THE GOLF SHOP STAFF WILL KEEP A LOG OF WHO IS ELIGIBLE FOR HANDICAP FLAGS AND WILL ALLOW THESE INDIVIDUALS A HANDICAP FLAG.
 - THE GOLF COURSE SUPERINTENDENT AND THE HERITAGE SHORES PROFESSIONAL STAFF RESERVE THE RIGHT TO NOT ALLOW HANDICAP FLAGS WHEN APPLICABLE.
 - ANY PATRON WITH AN ADA ACCESSIBLE GOLF CART WILL BE PERMITTED ACCESS TO THE GOLF COURSE AND USAGE OF THEIR GOLF CART AS LONG AS PRIOR NOTICE HAS BEEN GIVEN TO A MEMBER OF THE HERITAGE SHORES PROFESSIONAL STAFF.
- PATRONS WILL BE ALLOWED A TEMPORARY HANDICAP CART IF A DOCTOR'S NOTE IS RECEIVED BY THE HERITAGE SHORES PROFESSIONAL STAFF. THE GOLF SHOP STAFF WILL KEEP A SEPARATE LOG TO INDICATE WHICH PATRONS ARE ELIGIBLE. PATRONS MUST REAPPLY AFTER 30 DAYS.

DISABILITY/HANDICAP CARDS MUST BE SHOWN TO THE PROFESSIONAL STAFF PRIOR TO PLAY DURING NORMAL BUSINESS HOURS. PLEASE ALLOW 48 HOURS FOR APPROVAL. FINAL APPROVAL ON HANDICAP CART IS DETERMINED BY PGA DIRECTOR OF GOLF, BROOKS MASSEY OR PGA HEAD GOLF PROFESSIONAL, WILL SCARBOROUGH. IF MORE THAN ONE PATRON IN A GROUP REQUIRES A HANDICAP CART THEY MUST RIDE IN SAME GOLF CART.
